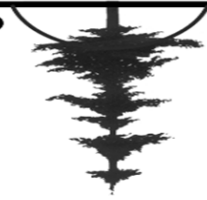

THIS WAIVER SHALL SERVE AS THE WAIVER FOR THE**

I hereby apply to participate in the Mud Volleyball Tournament in Cedar Springs, MI on August 15, 2010. I understand that participating in the tournament will expose me to above normal risks. These risks include uneven or hazardous playing surfaces, physical contact of collision with other players, spectators or inanimate objects on or about the court. I understand that the activity is in itself hazardous and may result in injury to me or other players. I represent that I have no health or physical problems that will interfere with my participation in the tournament.

I agree that I am responsible for my own safety. I hereby assume all risk associated with my attendance and participation in the tournament. I further agree that my attendance, play and participation in the tournament shall be at my sole risk and decision as to whether or how I play shall be entirely my responsibility.

I hereby fully release and discharge the Cedar Springs Area Parks & Recreation Board and its employees, the City of Cedar Springs and the Tournament Sponsors from any and all claims, causes of action or liability for any injury, loss or damage sustained or incurred by me arising out of or in any way associated with my attendance at or participation in the tournament, including all claims, causes of action or liability arising out of negligence of the Cedar Springs Area Parks & Recreation Board and its employees, or the City of Cedar Springs from any loss, damage or expense sustained or incurred by them, arising from any such claims, cause of action or liability, whether brought by me, or anyone acting on my behalf, or by anyone else because of conduct attributed to me.

I agree that this agreement shall be construed and interpreted according to the law of the State of Michigan. I agree with this agreement and release shall be binding upon my heirs, assigns and any personal entity acting upon my behalf, including parent, guardian of next of kin.

AGREEMENT REGARDING RISK OF INJURY AND RELEASE

6 on 6 Co-ed teams. Brackets are tentatively divided into the following four categories: 1) Age 14 and under 2) Age 18 and under 3) College 4) Adult open. Tournament officials reserve the right to adjust or combine divisions as needed based on registrations.

All players will receive a T-shirt; medals will be awarded to the top team in each division.

Teams may consist of up to 8 players; up to 6 players are allowed on the court at one time; at least 2 players must be of the opposite sex.

The fewest number on the court would be 4: 2 males and 2 females.

Tournament divisions on mud beach-size courts.

Check in at 12:00pm Matches starting approx. 1:00pm.

Registration is \$90 per team with a deadline of July 31st. Entries may be postmarked by that date. Each player or guardian must agree to the agreement regarding risk of injury and release. Each player's signature that they have agreed to the statement must be presented before a team will be allowed to compete.
